




Nicolas earned his BA in Economics at Stanford University.




#### HENRY ASZKLAR







Jeremy earned a Masters in Economics from MIT and a BSC with Honors in Mathematics from the University of Melbourne.




#### **BRAD GENTILE**




#### JOHN HICKENLOOPER

He entered public service as Mayor of Denver in 2003, where he focused on regional cooperation and urban development, and went on to serve two terms as Colorado's Governor from 2011 to 2019, overseeing economic growth, healthcare expansion, and climate initiatives.

In 2020, he was elected to the U.S. Senate, where he continues to advocate for pragmatic, bipartisan solutions on issues including energy, climate, and economic opportunity.

#### CHRIS LEARY






#### RICHARD MOON

Rob earned a BA from Hamilton College and an MBA in Finance from The Wharton School.




# BRAD SANDERS
