The property is situated off Midland Street which is accessed off Ashton Old Road (A635) which is a main arterial route linking Manchester City Centre with the M60 at Junction 23.

DESCRIPTION

The property comprises a steel portal frame warehouse with brickwork elevations under a pitched roof. The premises benefit from a shared secure yard area.

Unit 6A comprises offices situated at ground floor to the front of the property with open plan warehouse space situated towards the rear with the benefit of additional mezzanine storage above the offices. The unit has a roller shutter access to the yard area situated to the rear of the property which is accessed off Handsworth Street.


