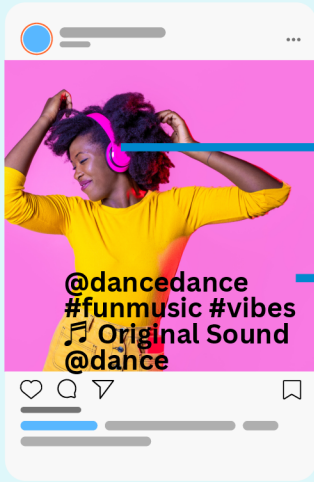

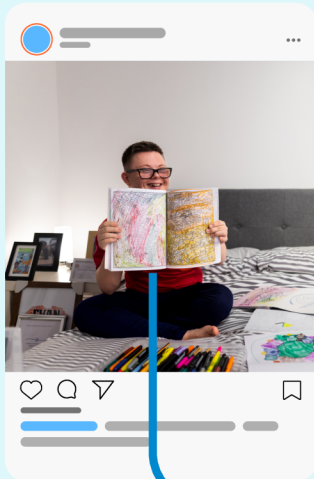

Product Affiliation

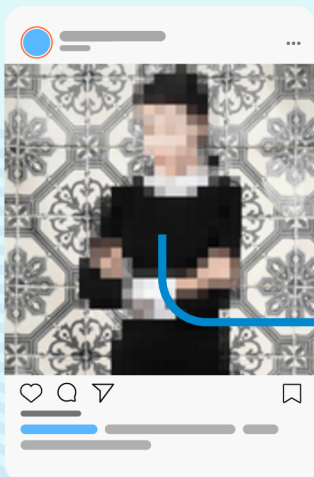
When you use a product's name or logo without permission, it can look like you're lying about a connection. This can confuse people, and punishment can include lawsuits or money fines.



IP ON YOUR FEED

Audio Use

When you use someone else's audio without permission, it's unfair because the creator worked hard to make it. This can cause problems like losing trust or even getting your work taken down, and you could face fines.



Your Art

When you share your art, others may copy or misuse it without credit. This can cause you to lose recognition, and punishment can include legal trouble or your work being removed.

Movie Clips

When you share movie clips without permission, it's harmful because movies belong to their makers. This can result in videos being deleted, your account suspended, or even fines in serious cases.

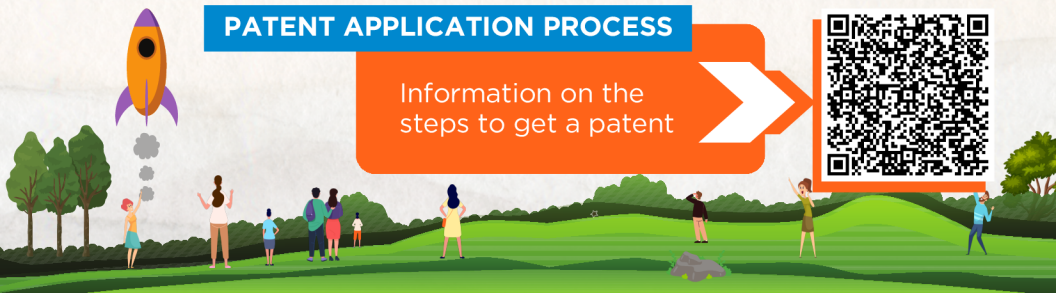
