The Notice dated 30th October, 2020 as confirmed by the Company was sent in respect of the below mentioned resolutions passed at the AGM of the Company through electronic mode to the shareholders whose email addresses are registered with the Company / Depositories, in compliance with the MCA Circular dated May 5, 2020 read with circulars dated April 8, 2020 and April 13, 2020 and SEBI Circular dated May 12, 2020.

Remote E-voting and Electronic voting during the AGM

- The e-voting facility both for e-voting prior to the AGM (remote e-voting) and Electronic voting during the AGM (e-voting) was provided by National Securities Depositories Limited ('NSDL')
- The Shareholders of the Company holding shares as on the "cutoff" date **18th November 2020** were entitled to vote on the proposed resolutions as set out at Item No's. 1 to 4 in the Notice of the AGM of Gillette India Limited.
- The voting period for remote E-voting remained open from **9.00 a.m. (IST) on 20 November 2020 to 5.00 p.m. (IST) on 24 November 2020** and the National Securities Depositories Limited ('NSDL') Remote e-voting platform was blocked thereafter.






