

VICTIM, OFFENDED PARTY, COMPLAINANT OR
COMPLAINANT INTERVIEW - WITHOUT LEGAL ADVICE

INTERVIEW OF: COMPLAINANT(s) PATRICIA DE OLIVEIRA SOUZA LELIS BOLIN.-In [REDACTED] at 2:53 PM FOURTEEN HOURS WITH FIFTY-THREE MINUTES on the 20th of the month of AUGUST of the year 2025, the undersigned agent of the Public Ministry proceeds to carry out the following investigation act record in accordance with the provisions of articles 21 of the Political Constitution of the United Mexican States, 108, 109, 110, 212, 213, 217, 221, 222 and 251 section XI of the National Code of Criminal Procedure, consisting of the interview with the person who said her name was PATRICIA DE OLIVEIRA SOUZA LELIS BOLIN, and who identifies herself with a DRIVER'S LICENSE credential, folio number [REDACTED] issued by UNDETERMINED, to whom it is made known that at any stage of the procedure he has the right to intervene himself or to appoint a Legal Advisor who must be a law graduate or a qualified lawyer with a professional license, who has the obligation to guide, advise or intervene, and in case of not being able to appoint a private individual, he will have the right to one of office, to which he stated that at the moment he does NOT wish to have the assistance of a Legal Advisor; and in general he stated: his name is as written, his sex is FEMALE, he is 31 years old, marital status *****, education *****, occupation *****, originally from *****, NOT APPLICABLE, NOT APPLICABLE, nationality *****, with current address at *****, *****, telephone *****, CURP *****. Likewise, in this act, the content of article 222, paragraph four of the National Code of Criminal Procedure is made known to him, who in this regard stated that he DOES file a complaint, and in relation to the facts being investigated, he refers:

THAT I VOLUNTARILY APPEAR BEFORE THIS SOCIAL REPRESENTATION, AND I WANT TO STATE THAT I DO NOT REQUIRE A TRANSLATOR, SINCE ALTHOUGH I SPEAK ENGLISH AND PORTUGUESE, I ALSO SPEAK AND UNDERSTAND SPANISH PERFECTLY, FOR WHICH AT THIS MOMENT I IDENTIFY MYSELF WITH A PASSPORT OF THE FEDERATIVE REPUBLIC OF BRAZIL, WITH PASSPORT NUMBER [REDACTED] ISSUED IN MY NAME, DATED OCTOBER 29, 2019, WHICH CONTAINS A PHOTOGRAPH, REQUESTING THAT A PHOTOSTATIC COPY OF IT BE ADDED TO THE INVESTIGATION FOLDER, I AM ALSO DULY INFORMED OF MY RIGHT TO BE ASSISTED BY AN ADVISOR LEGAL TO ASSIST HER IN HER INTERVIEW, TO WHICH I STATE THAT AT THE MOMENT I DO NOT CONSIDER IT NECESSARY AND THAT I WILL LATER REQUEST IT IF IT IS CONVENIENT, I ALSO REQUEST THAT HER PERSONAL DATA BE ADDED AND KEPT CONFIDENTIALLY, AND IN RELATION TO THE FACTS I WISH TO STATE THE FOLLOWING: IT IS THE CASE THAT THEY ARE OF BRAZILIAN NATIONALITY, BUT I ALSO HAVE AMERICAN NATIONALITY, THAT IS, OF THE UNITED STATES OF AMERICA, AND MY PROFESSION IS AN INDEPENDENT REPORTER, AND THAT I HAVE BEEN A TOURIST SINCE JANUARY 15, 2024, BUT I AM CURRENTLY CARRYING OUT THE PROCEDURES TO OBTAIN RESIDENCY IN [REDACTED] AND IT IS THE CASE THAT ON SUNDAY, AUGUST 17, 2025, AT APPROXIMATELY 04:00 HOURS WHILE RESTING AT MY HOME PREVIOUSLY MENTIONED IN MY GENERAL INFORMATION, I HEAR A GUNSHOT, SO I GOT UP AND GOED TOWARDS THE DOOR OF MY APARTMENT AND WHEN I OPENED IT I NOTICED THAT THE WALL OF THE ENTRANCE TO MY APARTMENT HAD SMALL DAMAGE TO THE WALL FROM THE SHOT, WITHOUT BEING ABLE TO FIND THE CARTRIDGE, IT APPARENTLY BACKED OFF AND HIT THE STREET, SO APPARENTLY YESTERDAY, TUESDAY, AUGUST 19, 2025, AT 6:23 IN THE P.M. I RECEIVED A MESSAGE FROM WHATS APP TO MY CELL PHONE AND IN THE MESSAGE WRITTEN IN ENGLISH AND THEY TEXTUALLY TRANSLATED INTO SPANISH THE FOLLOWING "I KNEW THE SHOT HADN'T HIT YOU, WHICH IS A SHAME, JULIAN AND I HOPED FOR THAT... BUT LOOK, DON'T WORRY, JULIAN WILL MAKE SURE IT WORKS NEXT TIME. AT LEAST NOW WE KNOW THAT YOU ARE CAUTIOUS AND HAVE BODYGUARDS. ARE THE PROJECT VERITAS JOURNALISTS TOO? WHAT DID YOU THINK? THAT SOMEONE IN THE GOVERNMENT WOULD SEE YOUR SAD STORY AND PROTECT YOU? CARLBERG IS NOT HAPPY WITH WHAT YOU DID, MAYBE SHE WILL EVEN ASK FOR YOUR DEATH PENALTY," FOR WHICH I HAVE THE WELL-FOUNDED FEAR THAT THEY MAY CAUSE HARM TO ME PERSONALLY AND I ALSO FEAR FOR MY LIFE SINCE THE PERSON WHO SENT ME THE MESSAGE IS ARMSTRONG WILLIAMS, WHO IS LOVIS, THAT IS, THIS SUBJECT WORKS FOR THE GOVERNMENT OF THE UNITED STATES OF AMERICA, OF WHICH I REQUEST THAT A COPY OF THIS SUBJECT'S PASSPORT BE ADDED TO THE INVESTIGATION FOLDER, AND I WISH TO STATE THAT THESE THREATS BY THE NOW ACCUSED ARE AS A RESULT OF SOME REPORTS THAT I PUBLISHED AS A JOURNALIST AND IN WHICH I MAKE REFERENCE TO THE CORRUPTION OF THIS SUBJECT WITH THE GOVERNMENT OF THE UNITED STATES OF AMERICA, WHICH I PUBLISHED ON AUGUST 12, 2025, SO IN AN APPROPRIATE TIME BEFORE THE AUTHORITY THAT CONTINUES TO KNOW THE FACTS, I WILL EXPAND MY CORRESPONDING INTERVIEW AND, IF APPROPRIATE, I WILL PROVIDE MORE DATA, WHICH IS WHY I FILE MY COMPLAINT FOR THE CRIME OF THREATS AND/OR WHATEVER RESULTS, AGAINST THE SUBJECT NAME ARMSTRONG WILLIAMS AND WHOEVER OR WHOMS ARE RESPONSIBLE, EVERYTHING BEING WHAT I HAVE TO STATE FOR THE MOMENT, AFTER READING MY STATEMENT, I RATIFY IT AND SIGN IT IN THE MARGIN FOR LEGAL RECORD.

Being all that you wish to express, for which in this act you file a COMPLAINT for acts possibly constituting the crime of THREATS - AN EVIL IN HIS PERSON, PROPERTY, HONOR OR RIGHTS OR IN THE PERSON WITH WHOM HE IS RELATED against ARMTRONG WILLIAM to the detriment of PATRICIA DE OLIVEIRA SOUZA LELIS BOLIN.

In this act it is made known that the Coordination of Legal Advisors, dependent on the General Directorate of Attention to Victims of Crime, with address at [REDACTED]

In [REDACTED] Federal District, at 2:52 PM, FOURTEEN HOURS AND FIFTY-TWO MINUTES on the 20th day of the month of AUGUST of the year 2025, based on the provisions of articles 14, 16, 21 and 122, section D of the Political Constitution of the United Mexican States; 127, 131, 211, 212, 217 and 221 of the National Code of Criminal Procedure; The undersigned agent of the Public Ministry leaves a record that the present Investigation Folder is initiated by virtue of the fact that the COMPLAINANT(s) who said his/her name was PATRICIA DE OLIVEIRA SOUZA LELIS BOLIN, appeared before this social representation, who comes to file a COMPLAINT for the crime of THREATS - AN EVIL IN HIS/HER PERSON, PROPERTY, HONOR OR RIGHTS OR IN THE PERSON WITH WHOM HE/SHE IS LINKED, estimated in the amount of 0 PESOS, being the COMPLAINANT(s) named PATRICIA DE OLIVEIRA SOUZA LELIS BOLIN and against the ACCUSED named ARMTRONG WILLIAM, according to events that occurred at FOUR HOURS WITH ZERO MINUTES hours on 08/17/2025 AUGUST SEVENTEEN (08) TWO THOUSAND TWENTY-FIVE, [REDACTED] by virtue of THE COMPLAINANT REFERS THAT ON SUNDAY, AUGUST 17, 2025, AT APPROXIMATELY 4:00 AM, A GUNSHOT ENTERED HER HOME, BUT IT DID NOT CAUSE ANY INJURY. SUBSEQUENTLY AFTER THIS, SHE RECEIVED A MESSAGE BY WHATS APP THAT THE NEXT TIME THE SHOT WAS GOING TO BE DIRECTLY FOR HER.
