MY 2020 LOOK BACK

Dear Friends, Supporters, and Patriots:

2020 was an historic year for our country and Project Veritas. It was an election year marred by a health crisis, violent unrest and overall uncertainty. Project Veritas still accomplished its mission of exposing widespread corruption, malfeasance and dishonesty within public and private institutions.

This year proved once again that our team is indefectible and will always fight for truth, no matter the circumstances.

What Project Veritas has done since the beginning of 2019 is harness the skills of our Undercover Journalists while also being the only true home for Brave Insiders that want to blow the whistle on wrongdoing within their institution. This model has led our organization to publish stories such as CBS' fake COVID testing line at Cherry Health Clinic, Facebook's political bias and censorship, Minnesota's Ballot Harvesting and Cash-for-Ballots scheme, and multiple USPS Insiders blowing the whistle on Election Fraud. These were some of the most impactful stories for Project Veritas since it was founded in 2011.

Insiders lead to more Insiders

I can't stress enough how important it is to recruit and protect these brave patriots who come to us with inside information. They put their livelihoods on the line because they care about the truth, and they now know that Project Veritas is the only place that will tell their story.

I will never forget what one of these brave individuals once told me: "I came to Project Veritas because I couldn't go to The New York Times or The Washington Post, they would have colluded with my employer and thrown me under the bus."

These individuals have also inspired others to come forward with their stories. Facebook Insiders Zach McElroy and Ryan Hartwig told me that they were inspired to speak out because of our



Pinterest story and Google stories from 2019. Pinterest Insider Eric Cochran and Google Insiders Zach Vorhies and Greg Coppola were catalysts in that sense. Furthermore, the brave Pennsylvania USPS whistleblower Richard Hopkins was also inspired by our Michigan USPS whistleblowers. There is no doubt that Insiders lead to more Insiders.

The truth is, no other organization is doing what Project Veritas does. No other organization is willing to pursue the truth and take the risks in the way that we are.

Our goal for 2021 is to increase the number of Insiders that come to Project Veritas while continuing to nurture our Undercover Journalists, so that they are equipped in the field and can do what they know to do best.

2020 Project Veritas Impact

I couldn't be prouder of what this team was able to accomplish this year. It gives me even more hope that 2021 will be our biggest year yet. As you'll see in the upcoming pages of this booklet, some of our biggest stories in 2020 were:

- Exposing ABC News' Senior Correspondent David Wright, who admitted that his network does not cover news objectively;

- Cherry Health Clinic Insider recording his colleagues saying that a fake COVID testing line was manufactured because it would air on CBS News;

- Antifa's organization, violent training and dark money funding;

- Rep. Matt Gaetz (R. – Fla.) sending the Justice Department a criminal referral letter targeting Facebook CEO Mark Zuckerberg for his alleged perjury after he testified Facebook does not censor political speech – all based on a Project Veritas investigation;

- Conversation with New Hampshire Attorney General Gordon MacDonald to discuss why his office covered up Vincent Marzello's double voting file for months;

- Hosted by Sean Hannity on Fox-News to discuss illegal Ballot Harvesting that took place in Minnesota;

- Exposing and confronting violent Colorado Democrat leader Kristopher Jacks;

- Texas Governor and Attorney General announcing investigation into illegal Ballot Harvesting in their state due to Project Veritas' investigation

- Exposing deceptive campaign tactics by Senate candidates Amy

McGrath, Jon Ossoff, Mark Kelly and others

- Brave USPS Insiders in Michigan and Pennsylvania blowing the whistle on backdating postmarks on late ballots for Nov. 3, Election Day

These stories received national and international media coverage, and it forced authorities and elected leaders to pay close attention to Project Veritas' work.

President Donald J. Trump himself mentioned or tweeted about the CBS story, Minnesota Ballot Harvesting story, and USPS story.

This sort of impact has consolidated Project Veritas as a force to be reckoned with.

Of course, our success comes with a cost. The usual media hacks have attacked our work relentlessly as a way to undermine our credibility. The New York Times published multiple defamatory articles about the Minnesota Ballot Harvesting story including one titled "Project Veritas Video Was a 'Coordinated Disinformation Campaign,' Researchers Say." This article proved absolutely nothing of what it claimed, and we have now filed a lawsuit against The New York Times for this libelous piece.

After brave USPS whistleblower Richard Hopkins went public and attested to the backdating of ballots in his Erie, Pennsylvania post office, The Washington Post published a piece claiming that Hopkins had in fact recanted his original statement. Then, CNN's Anderson Coop-

er brought on The Washington Post's Jacob Bogage, one of the article's authors, to amplify his ridiculous claims.

Here's the truth: Hopkins never recanted, and there is nothing the media can say to alter that reality.

We will never be defeated nor demoralized by the corrupt media's lies or Big Tech's ongoing censorship of our videos. We will always fight back.

president Randi Weingarten, announced a lawsuit against the state of Oregon for their draconian laws against undercover recording, and we are now suing The New York Times for defamation.

In addition to those cases, a federal judge ruled in favor of Project Veritas on two counts asserted by Clinton-connected 'Democracy Partners,' and the FBI removed me from their NICS list after

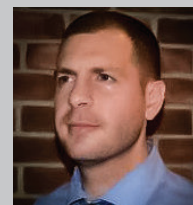

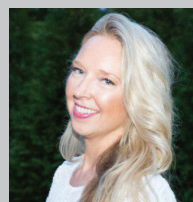
Joe Halderman - Executive Producer

When Project Veritas journalists engaged ABC News senior correspondent David Wright the night of the New Hampshire primary in a Manchester bar, he told them that his bosses did not give President Donald J. Trump fair coverage and were more interested in promoting Marvel heroes and Disney princesses for Disney, their corporate parent. When a journalist asked Wright if he was a Democratic Socialist, he said no, he was straight-up socialist.

IMPACT: ABC News suspends Wright and upon his return takes him off all political stories.

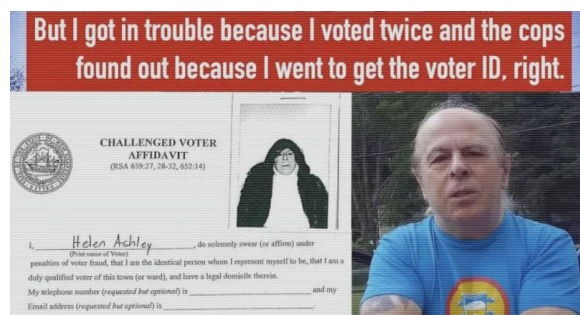

NEW HAMPSHIRE ATTORNEY GENERAL'S OFFICE COVERS UP DOUBLE VOTING FELONY

Project Veritas exposed a double voter in the state of New Hampshire by the name of Vincent Marzello. He was recorded admitting to double voting in the 2016 election, but the New Hampshire Attorney General's office never prosecuted him even while having a file with the information necessary to arrest him.

IMPACT: As a result of Project Veritas' investigation, New Hampshire's Attorney General Gordon MacDonald ordered Marzello to be arrested. Marzello has now been indicted for committing voter fraud.

TEXAS BALLOT CHASER CAUGHT ON TAPE COERCING VOTERS

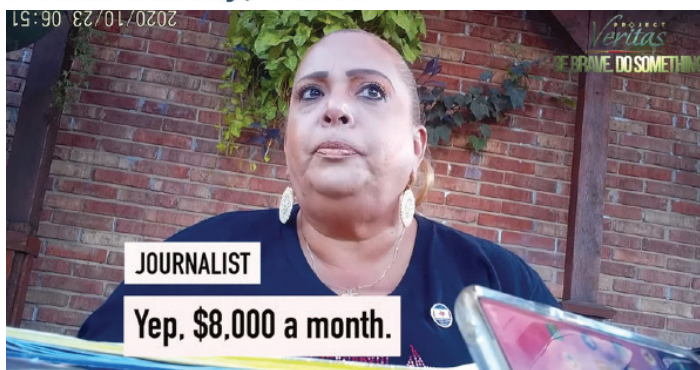
Project Veritas videos exposed a self-described ballot chaser, Raquel Rodriguez, who admitted to buying votes and manipulating people to vote for her preferred candidate. Rodriguez also said she had multiple politicians and judges in her pocket that supported her in her voter fraud schemes.

IMPACT: Texas Attorney General Ken Paxton announced an investigation into the matter. Texas Gov. Greg Abbott also said that these actions were unacceptable, and that Texas does not tolerate voter fraud.

CBS NEWS BROADCASTS FAKE COVID-19 TESTING LINE AT GRAND RAPIDS, MICHIGAN CLINIC PARKING LOT

“CBS This Morning” host Gayle King introduced a segment on the status of COVID-19 testing in Michigan. Part of the story was the long line of cars at drive-up testing site in the parking lot of Grand Rapids’ Cherry Health clinic. A clinic insider tipped off Project Veritas and wore a hidden camera to record people there about how the line was staged for the cameras—because normally there are no lines.

IMPACT: CBS News blamed the clinic’s staff for the staged line and deleted the segment from its website. Also, President Donald J. Trump referred to the incident in the Oval Office.

MINNESOTA BALLOT HARVESTERS EXPOSED IN MASSIVE CASH-FOR-BALLOTS SCHEME



Facebook content moderators Zach McElroy and Ryan Hartwig, both wore hidden cameras for more than four months recording other moderators expressing how they censor content and comments supporting Trump, as well as Republican causes and candidates. They also documented how Facebook allows hate speech against Republicans as exceptions to its policies. This conduct contradicted sworn Capitol Hill testimony by Facebook CEO Mark Zuckerberg that Facebook only censors hateful and violent speech, not political speech.

IMPACT: Facebook said the conduct Project Veritas documented was wrong and they would improve their training. Rep. Matt Gaetz (R.-Fla.) contrasted Zuckerberg’s testimony with our report and filed a criminal referral with the Justice Department demanding a perjury investigation.

A Project Veritas investigation uncovered rampant ballot harvesting fraud taking place in Minnesota, specifically within the Somali community of Minneapolis. Liban Mohamed, a ballot harvester featured in the videos, bragged about having 300 ballots in his car. Several sources and other ballot harvesters in the video made a direct tie between Rep. Ilhan Omar’s campaign organization and the Minnesota ballot harvesting scheme.

IMPACT: The Minneapolis police department announced an investigation into this matter. President Donald J. Trump asked the local U.S. Attorney to investigate.

“I was seeing them interfering on a global level in elections. I saw a blatant exception that just targeted conservatives or favored liberals—and you know, we’re deleting on average 300 posts or actioning 300 posts a day.”

Hartwig is the second Facebook Whistleblower Project Veritas debuted to report on the behavior. Recordings captured Facebook content moderators bragging about deleting posts and comments supporting President Donald Trump and conservative causes.

Hartwig was employed by Cognizant the same third-party company we reported to have contracted with Facebook to conduct content moderation. Cognizant content moderators are called “process executives” and they use Facebook’s review queue to adjudicate whether a post or comment should be allowed, taken down or escalated to a supervisor.

Hartwig wore a hidden camera to document reviewing of content and office interactions. In an interview with Project Veritas CEO James O’Keefe, Hartwig said although he signed a confidentiality agreement, he could no longer ignore the suppression of Facebook content supporting President

Donald Trump, Republican causes or the conservative agenda with a massive exception to the company’s public position on protecting political speech across the platform.

“That was the tipping point. knowing about what I knew about how they were giving exceptions for the policy, I knew that it was likely that it was happening elsewhere on a global scale,” he said. “Just seeing such blatant bias from Facebook really bothered me.”

O’Keefe said Hartwig exemplifies the heroic virtues of Project Veritas’ “Be Brave. Do Something.” campaign.

One of the moderators Hartwig recorded was Israel Amparan, who he said typifies the worldview of most of the content moderators he encountered.

“Trump supporters are f*cking crazy *ss *sshholes, that every other f*cking word out of their mouth is you know ‘Come take it,’ ‘Seal the border,’” said Amparan. “Come take it” refers to the “Come and Take It” slogan Texan colonists put on their flag after the Mexican government demanded they turn in their cannon.

Amparan said he targeted content by Trump supporters because it scared him.

“I hate government as much as the next f*cking person, but you’re not gonna catch me riding over the f*cking. It’s like impeachment. It’s like a PRAW. Trump called it a f*cking coup--and it’s like that should scare you more than anything.” A PRAW, or Python Reddit API Wrapper, is a Reddit program to allow user to more quickly and easily post on Facebook.

Hartwig also videotaped Steve Grimm, who is a team lead at Facebook-Cognizant’s content review—and who said Trump supporters are in the same speech category as Hitler, under the Facebook policy on Dangerous Individuals and Organizations.

“One of my projects before now was, was hate,” Grimm said. “I’ve spent quite a bit of time looking at pictures of hate organizations, Hitler, Nazis, MAGA, you know, Proud Boys, all that stuff all day long.” MAGA is the acronym for Trump’s 2016 slogan: Make America Great Again.

Facebook CEO Mark Zuckerberg testified before Congress the only speech Facebook targets for deletion is speech advocating hate, violence and terrorism, but not political speech.

“Zach McElroy’s story raises serious doubts about the Capitol Hill testimony of Facebook CEO Mark Zuckerberg, who gave lawmakers the impression that his company only takes content that could cause harm, such as relating to terrorism or hate speech, but never for politics,” said James O’Keefe, Project Veritas’ founder CEO.

“Facebook and other social media platforms are protected by Section 230 of the Communications Decency Act, because they claim that unlike traditional publishers that do not actively edit content—they say they are like the phone company just stringing wires on poles,” said O’Keefe.

“Facebook’s \$400 billion market capitalization is tied to this protection and

our report shows for the first time anywhere Facebook’s robust and human-directed process for restricting the marketplace of ideas, which calls into question their CDA 230 immunity,” he said.

In one example, McElroy captured as a screenshot, President Donald Trump posted on Facebook about Republican successes, including electing a GOP governor of Mississippi. In the screenshot, Trump’s account is labeled “Verified and Shielded,” but a seemingly innocuous comment on the post: “Cleaning up the house” with heart emojis is flagged in the Single Review Tool for adjudication.

One of the content moderators was asked if she deleted every Republican item that came up on her queue, she said: “Yes! I don’t give no f*cks, I’ll delete it.”

The same moderator said she does not take down anti-Trump content, even if it did violate policy.

“You gotta take it down but I leave it up,” she said. “If you see something that’s not supposed to be up, it’s probably me.”

Another content moderator, Lara Kontakos, was asked what she did when she saw posts supporting the president: “If someone is wearing a MAGA hat, I am going to delete them for terrorism.”

Then, Kontakos looked around at her colleagues: “I think we are all doing that.”

Steve Grimm, a content review lead, said it was Facebook’s culture to target the president and his supporters. “It’s a very progressive company, who’s very anti-MAGA.”

Hate speech with the right. Anything in regards to hate speech, you cannot advertise.



[LONDON—Oct. 20, 2020] A Google advertising account executive told a Project Veritas journalist with a hidden camera how he and his company exploit its market dominance to advance a political agenda and suppress opposing political views.

“You can offer free credits, free advertising credits, to Democratic parties for advertising,” said Adriano

Amaduzzi, a technical account manager at Google Marketing.

Amaduzzi said on the other hand, Google can suppress Republicans using the so-called Trust and Safety team. “You can, potentially--censor out news from your search engine.”

James O’Keefe, the founder and CEO of Project Veritas, said Amaduzzi’s comments are consistent with

other Project Veritas investigations into how social media giants manipulate speech and content.

“Recently we’ve seen censorship of free thought and stories from the Big Tech giants. Many believe this kind of editorial suppression will affect the upcoming election,” O’Keefe said. “But it seems the biggest tech giant of them all—Google—may have other ways to impact the election—this time coming from their ad sales division overseas.”

Amaduzzi even bragged to the Project Veritas journalist about how he chose to ignore a request for pro-Brexit ads to be placed on Google and its platforms.

Journalist: “Because you’re the gatekeeper of Google, what you’re going to allow to advertise. So, if they want to promote it—”

Amaduzzi: “No, not really, I wish I was that influential. I’m just one of the pawns.”

[Silicon Valley, Calif.—Oct. 21, 2020] One of the most senior leaders in Google’s Cloud division told a Project Veritas journalist exactly how the search engine and social media giant manipulates how users act and feel politically.

“All of the social media and the online platforms know your political leanings,” said Ashwin Agrawal, the head of global competitive analysis at Google Cloud. “Now, the more you see a Biden ad, the more, you know, passionate or the more sort of leaning you’re going to come for Biden.”

James O’Keefe, the founder and CEO of Project Veritas, said, “Google is the most dominant Big Tech company in the world and its power to shape our politics is very scary.”

Agrawal said Google algorithms identify Democratic voters and work to keep them as Democrats.

“If you’re a Democrat and you see more and more Democrat, you’re not

given an opportunity to change your mind,” he said.

[SAN JOSE, CALIF.—Oct. 19, 2020] A senior Google manager exposed the search engine and social media giant's suppression of speech and democracy in a Project Veritas report released today.

"I feel suffocated at Google," said Ritesh Lakhkar, a technical program manager in Google's Cloud division, to a Project Veritas undercover journalist. "Because on one side you have this professional or unprofessional attitude, and on the other side, you have this ultra-leftist attitude, and your entire existence is questioned."

Lakhkar said Google exercises deity-like control over the information Americans receive.

"You're like playing selective God," he said.

"If it was fraud, it doesn't matter, but for Trump, Melania Trump, it matters, and on the other side, Trump says something, misinformation, you're gonna delete that because it's illegal under whatever pretext," he said. "If a Democratic leader says that, then you're gonna leave it like that, so I'm like, okay, you're not following one way or the other. You are just plain and simple trying to play God."

James O'Keefe, the founder and CEO of Project Veritas, said, "Ritesh Lakhkar told our journalist the truth about Google, the company he has worked at for years. With the presidential election just days away, he is calling out Big Tech."

Ritesh Lakhkar: "I can't keep doing this. Go and teach Chinese people how to do American jobs and come back and get surveilled on the way."

Journalist: "Were you doing that for Google?"

Lakhkar: "Google, FitBit. Yeah. Those two companies, primarily."

Journalist: "So, you were going there and working for Google in China?"

Lakhkar: "Yeah."

Journalist: "Wow. That's scary. I'm scared they're gonna start doing stuff like that here."

Lakhkar: "Yeah. And when you have these candid conversations with your friends who are centrist or Republicans, then you wonder, all of a sudden, like, 'Oh, I should vote for Trump.'"

Lakhkar told a Project Veritas journalist that playing God with Google users and YouTube made him uncomfortable and he wants to leave Google. "Yeah, it doesn't jive with me."

Journalist: "You guys own YouTube, too, right?"

Ritesh Lakhkar: "We play God with that, too."

Lakhkar said on the Google-owned YouTube, the search engine giant deletes all controversial content. "It's not a good thing and I agree with that, but if it's freedom of speech, both sides need to get their opinion."

The Google technical program manager said it was a part of the Google culture that is making him conflicted.

"Morally and ethically I disagree," he said.

Journalist: "I mean, the leftists must be in charge, I imagine."

Ritesh Lakhkar: "I don't know that, I don't know that. Because the founders were ultra-leftist, we know that, but Sundar [Pichai], I'm not sure."

Lakhkar said an example of Google's leftwing culture was the

reaction to Donald J. Trump's 2016 election as president.

"When Trump won the first time, people were crying in the corridors of Google. There were protests, there were marches. I guess, group therapy sessions for employees--organized by HR," he said.

"There were days, like: 'Okay, don't come to work. We understand this is like a shocking event. Take some time off and cool off and we'll regather again to figure out our strategy,'" he said. "That kind of stuff--I'm like--are you serious, are you kidding me?"

Lakhkar said he worked for other major industrial and medical companies, and none of them had the leftist culture he deals with at Google.

"When I worked for Caterpillar or Corning, politics didn't really matter," he said. "You just do your job and: 'Let's make tractors, let's make glass.'"

VOTER FRAUD MINNESOTA



[Minneapolis – Sept 29, 2020] In part two of an explosive exposé, a Minnesota-based source tells Project Veritas that the mastermind behind the rampant voter fraud scheme is Rep. Ilhan Omar (D-Minn.) herself and her extensive political machine.

“Nobody would say that Ilhan Omar isn’t part of this,” said Omar Jamal, a Somali community Insider and the Chairman of the Somali Watchdog group. “Unless you’re from a different planet, but if you live in this universe, I think everybody knows it.”

Jamal said Ali Isse Gainey, a senior Ilhan Omar staffer, is at the center of the vote-buying scheme.

Monday’s Project Veritas report implicated Ilhan Omar staffer Ali Gainey Isse and other Ilhan Omar operatives in conduct related to voter fraud, ballot harvesting, harvesting ballots from seniors and bribery, that is, exchanging ballots for cash and paying precinct managers and election judges.

“She’s [Ilhan Omar] the one who came up with all this [pay-for-vote],” said one source who added. “She’s [Ilhan Omar] the one, somehow. Nobody knew, but, yeah, this is

something like new with Ilhan [Omar].”

Jamal Omar said cash for votes is an open secret in Minneapolis. “The techniques that he [Ali Isse] uses to exchange money for vote -- that’s not a secret. It’s, it’s open, and everybody knows about it,” he said. “\$200, \$300 per ballot received!”

It cost me \$2,000,” he said. “Still, I still have to pay Al-Shabaab to leave me alone--Al-Shabaab, they are demanding \$1,000.”

Dahaquane said when it comes to ballot harvesting, even the election judges are in on it.

works with the Ramsey County Sheriff Department and is the chairman of the Somali Watchdog Group. "I have been involved in the community for the last 20 years."

Jamal said he was motivated to reach out to Project Veritas, because he wants to eliminate the corruption that weakens his community, such as the ballot harvesting practiced by Minnesota's Democratic-Farmer-Labor Party, in which Ilhan Omar has emerged as a rising power broker.

"It's an open secret," he said. "she [Omar] will do anything that she can do to get elected and she has hundreds of people on the streets doing that."

Ballot Harvester described how his own ballot was harvested by Omar operatives.

"They come to us. They came to our homes. They said: 'This year, you will vote for Ilhan,'" he said. "They said: 'We will make the absentee ballots. We will fill out the forms for you and when you get them back, we will again fill it out and send it.'"

There was no need to go to the voting site, because the Omar operatives told him: "You stay home and you will not go to the place."

After the ballots are signed and documented the harvester said he got paid.

"When we sign the voting document and they fill it out is when they give us the money," he said. "The minute we signed the thing [ballot] for the election. That's when we get paid."

CONCORD, N.H. – As a direct result of a Project Veritas investigation, a case of double voting in the Granite State is now being prosecuted by the state's Attorney General Gordon MacDonald, who announced today that Vincent Marzello of West Lebanon, NH, was arrested and charged with Felony voter fraud for voting twice during the 2016 General Election.

Initially, the New Hampshire State Police investigated Marzello starting in August 2019, and then the State Police delivered the case file—which included evidence that Marzello voted twice—to Dick Tracy in the Attorney General's office in December 2019.

"Only after Project Veritas filmed Vincent Marzello, did it come to light the State Police reported the case to the AG's office nearly a year ago. It appears while simultaneously cooperating with the state Democratic Party to save face for appointing an admitted double voter, as an election inspector, the AG's office refused to prosecute until Project Veritas forced their hand by storming their office yesterday," said James O'Keefe Project Veritas Founder and CEO. "The arrest of Marzello is a direct result of a Project Veritas investigation. Why does the AG's office wait until Project Veritas investigates to act on fraudulent behavior?"

The New Hampshire Democratic Party appointed the double voter, Vincent Marzello, also known as "Helen Ashley," as an election inspector for the 2020

election under his female alias.

New Hampshire State Police Trooper 1st Class James Decker told Project Veritas he investigated Marzello for double voting after Marzello attempted to secure the

second photo ID required by the state's 2012 voter integrity law. The trooper specializes as a fraud inspector with an emphasis in false and stolen identities.

"...I can tell you that about little more than a year ago, I was alerted to a call where somebody was trying to fraudulently obtain a voter ID card. This person had shown up at—I believe—it was a Claremont DMV office and a voucher for a New Hampshire voter ID card. Something seemed amiss. They had, they claimed to have no other, no other ID,

and voted in person at the polls in New Hampshire."

The state Attorney General stated: Marzello was charged with a Class B Felony for violating RSA 659:34, I (b) for knowingly voting more than once for an office or measure for voting twice in the City of Lebanon, during the November 8, 2016 General Election, by voting once as Vincent Marzello and once as Helen Elisabeth Ashley.

In addition, a civil enforcement action was commenced against Mr. Marzello, pursuant to RSA 659:34, I (c), for applying for and obtaining a ballot in a name other than his own during the November 8, 2016 General Election, by using the name Helen Elisabeth Ashley.

This office has been in communication with the City of Lebanon's election officials regarding the allegations against Mr. Marzello.

This office also learned that the New Hampshire Democratic Party had appointed Helen Elisabeth Ashley as

"The Granite State appears to be plagued with fraudulent electioneering," O'Keefe said. 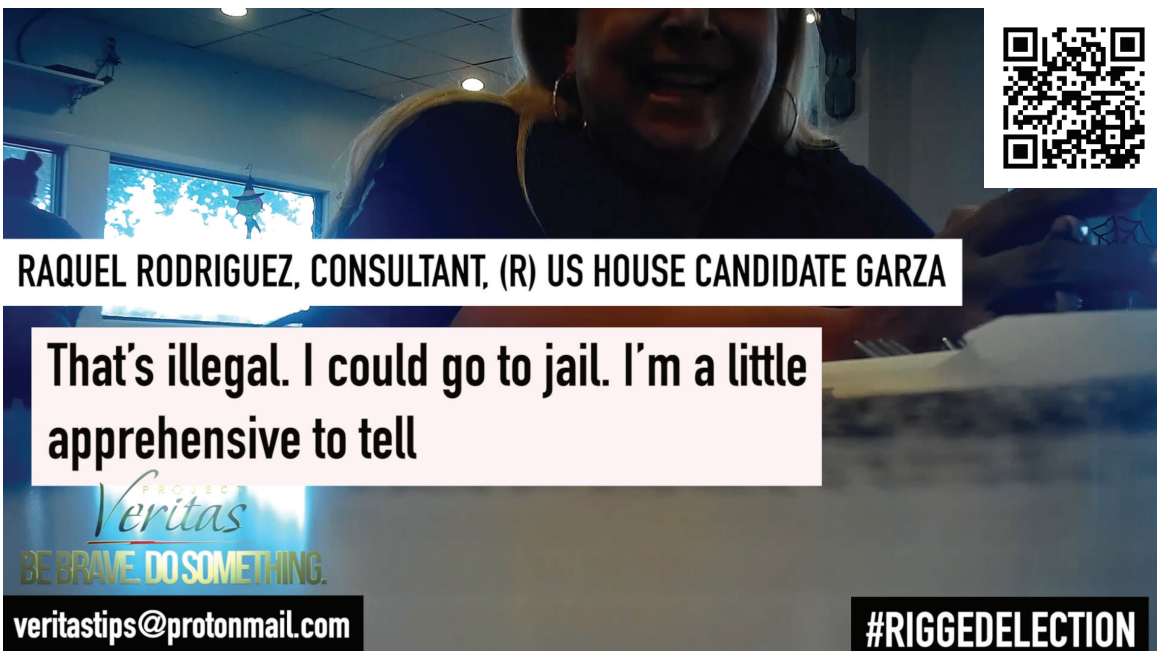

[ERIE, PA.—Nov. 5, 2020] Project Veritas released an interview with another U.S. Postal Service worker, where the worker described how his leadership here ordered all late ballots to be postmarked for Nov. 3, Election Day.

“All these ballots that were coming in—today, tomorrow, yesterday—are all supposed to be postmarked the third,” said the postal service employee, who works out of the USPS General Mail Facility here.

The Project Veritas Insider said the supervisors are collecting the ballots and making sure they are postmarked.

“They’re getting these ballots in and they’re getting, they’re taking them from us,” he said.

“We have to separate out the ballots and give them directly to the supervisors,” he said. “They’re postmarking and they’re at the office and taking them directly to the ballot box.”

James O’Keefe, the founder and CEO of Project Veritas, said the Insider’s story lines up with a similar story told by a postal service employee in Traverse City, Michigan.

“This revelation is a shock to every American, who put their trust in the post office this election,” O’Keefe said.

Candidate Donald J. Trump beat former first lady Hillary R. Clinton in Erie County, Pennsylvania by less than 2,000 votes in the 2016 presidential election.

Trump was the first Republican to win the county, since 1984, when President Ronald W. Reagan won his second term.

In the 2020 presidential election, Erie County is again hotly contested by Trump and Vice President Joseph R. Biden Jr.

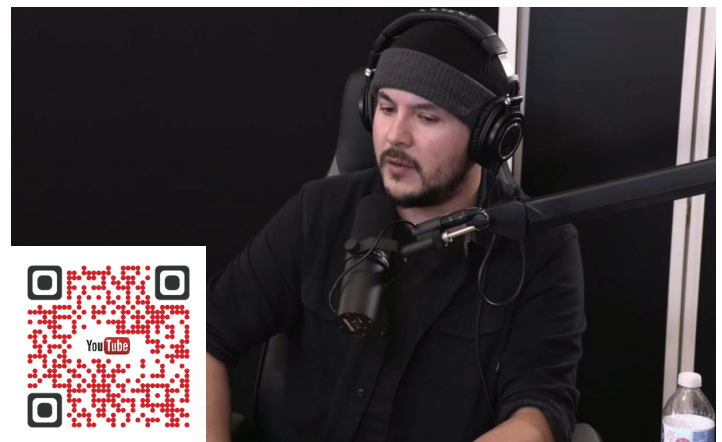
listeners have this began," Weinstein said.

“It reminds me of what we heard from the CEO of Reddit,” he said. “He actually said: ‘I’m confident Reddit could swing an election. We wouldn’t do it.’ Then, what do they do? Now, they’re actively censoring, you know, conservatives, Trump supporters, so, we’re seeing this kind of thing just basically across the board.”

O’Keefe said he and his Project Veritas are one of the last practitioners of undercover journalism, which he combines with video, the most reliable medium for conveying quotes to the public.

“Deceptive editing is—I mean, all journalism is edited in a selective fashion,” he said.

“Words are arranged onto newsprint. Bob Woodward in his book, “Fear,” and the new book, which—I don’t even know the name of the new book he wrote—but, Bob Woodward uses deep background sourcing, and something that Tom Wolfe invented, like this new journalism,” he said.

“This thing where, Tim, he meets with a source, and the source tells him a story on hearsay, and then he puts the quotes from the one source in other quotes, and he tells it like it’s a direct quote. What is that if not selective editing? Our stuff—every word, you can see the person’s lips moving,” he said.

“It’s asinine if you actually think—it’s pathological if you think about it, that journalists, like Bob Woodward, who quote people, who quote other people, and then he puts that stuff in quotes, is saying that I selectively edit, when you can see the person’s lips moving,” he said.

“It’s worse than 1984,” he said. “As Gavin McInnes says: ‘It’s become almost a Kafka-esque nightmare.’”

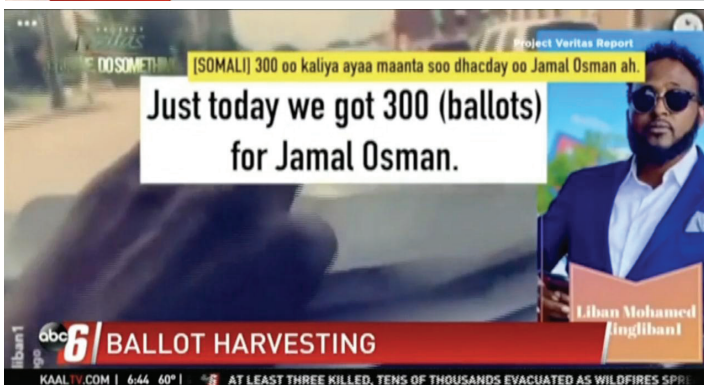
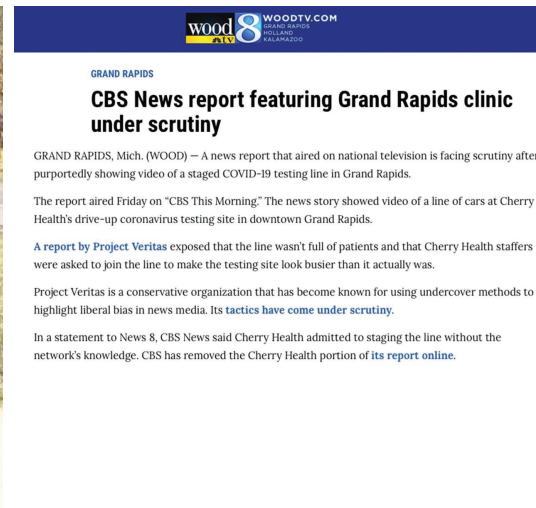
The online report suggested the footage shows a scene that may have been staged.

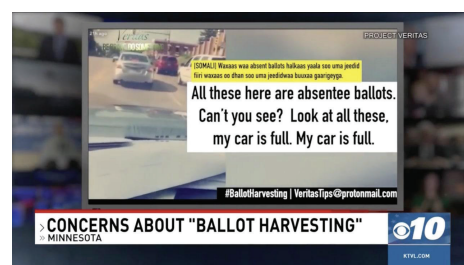

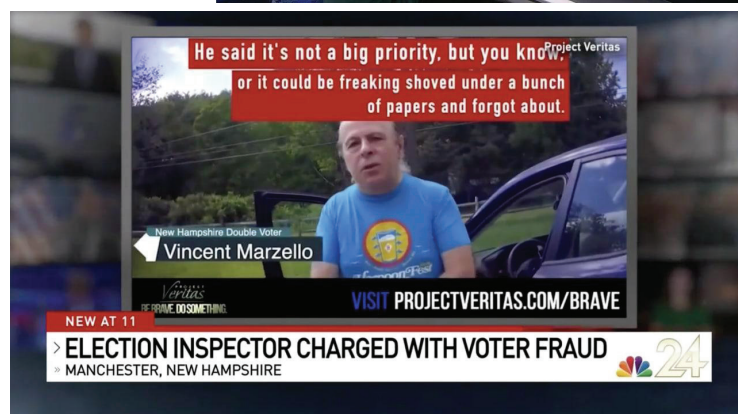

TRUMP SUES CNN



President Donald Trump's reelection campaign committee filed a federal defamation lawsuit in the District Court of Northern Georgia with a petition that quotes extensively from Project Veritas reporting.

"Thanks to our brave insider Cary Poarch, we were able to expose the active bias Jeff Zucker, the chairman of Warner Media News and Sports and the president of CNN Worldwide, has ingrained in the culture of that once-proud organization," said James O'Keefe, the founding CEO of Project Veritas.

The lawsuit said: "Cary Poarch, a CNN employee in the Washington, D.C. bureau, states in the Project Veritas footage that CNN 'purports to be facts first, and that's clearly not the case.'"

O'Keefe said Poarch took tremendous professional and personal risks to expose Zucker's mandates to attack the president and how its leftwing culture dominates and informs its reporting.

"The Trump campaign cites us for two pages of a nine-page document because we were able to report that even CNN staffers were upset about the anti-Trump mandates put out by Zucker every morning in conference calls Cary recorded and we made public," he said.

The lawsuit was triggered by a

CNN report that stated that the Trump campaign sought help from the Russians in the 2020 election cycle, according to the filing.

"CNN clearly had a malicious motive in publishing the defamatory article and acted with reckless disregard for the truth. Extensive public information, known by and available to CNN, confirms that the campaign has not sought Russian help in the 2020 election and has made no statements about seeking any such help," the campaign said.

The campaign further alleged: "CNN's actions show willful misconduct, malice, fraud, wantonness, oppression and that entire want of care which raises a presumption of conscious indifference to the consequences, and accordingly the Campaign is entitled to an award of punitive damages against CNN."

Defamation is the deliberate damaging of a reputation and the Trump campaign used quotes from Project Veritas reporting to establish that CNN was motivated by animus.

"It is not entirely surprising that CNN would publish such blatantly false statements about the Campaign. There is extensive evidence that CNN and its writer, Larry Noble, are extremely

biased against the Campaign. This evidence includes, among other things, undercover video footage taken by the Project Veritas news organization in which CNN staff members admit on camera that CNN's coverage is extremely biased against the Campaign, the administration, and Republicans in general."

Here is another example the campaign cited from Project Veritas reporting that speaks directly to how CNN connected the president to Russia:

"In the Project Veritas footage, Nick Neville, a media coordinator at CNN, admits that CNN's chief executive, Jeff Zucker, has a personal vendetta against the president. John Bonifield, a supervising producer at CNN, states in the Project Veritas footage that CNN's coverage regarding Russia's alleged interference with the 2016 election was "mostly bullshit" and that the president "is probably right to say...you are witch-hunting me."

O'Keefe said one reason why Project Veritas reporting can be cited in court documents is that PV does not use anonymous sources. "We record what people actually say as they actually say it. What we recorded at CNN proved that the outlet had reneged on their mission to report the news without bias."

This report is the second phase of Project Veritas' ongoing investigation into ABC News—following up on the insider-provided tape of news presenter Amy Robach's hot-mic lament that her ABC News bosses spiked her comprehensive report on Jeffrey Epstein.

"We would not put it on the air," Robach said. "It was unbelievable what we had, Clinton, we had everything."

Wright: "Yeah, I think, you know, Bernie is very old and I think he doesn't want to admit that. Bernie is also I think he- like he believes in the movement that he started. And, he did really, he was John the Baptist; you know but he doesn't need to be a messiah."

He went on to say that he puts his hope on Sen. Elizabeth Warren (D.-Mass.) to be the practical choice for president. "Setting aside my professional dispassion, I worry that if he's [Sanders] elected, he's not going to get anything done. Because he hasn't gotten anything done. Where I do think Warren taking those same issues could get something done."

Sanders won the New Hampshire Primary with 26 percent of the Democratic ballots cast with Warren finishing fourth with 9 percent.

ABC News told Project Veritas it would comment on these videos, but had not responded with that comment before deadline.

2020: THE YEAR IN RETRACTOS

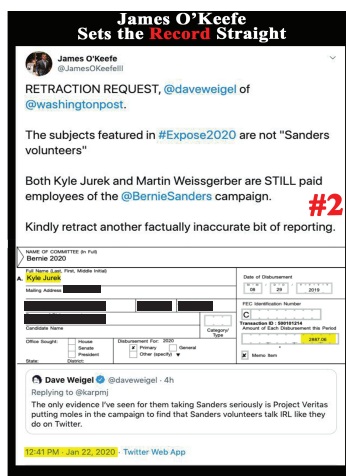
The Project Veritas “Wall of Shame” is the place where the reputations of journalists and editors go to die.

There were 21 retractions, corrections or outright deletions by reporters and or their outlets in 2020. Sadly, there is no sign this will get any better in 2021. Until it does, Project Veritas is going to continue to hold journalists and editors accountable.

Retractio #307 – Dave Weigel, Slate Jan. 17

While at Slate in 2013, Washington Post’s Dave Weigel claimed that Project Veritas taped ACORN’s Juan Carlos Vera “without consent,” alleging an invasion of privacy in his complaint; however, he did not allege defamation and it is false that he was “portrayed untruthfully.” Project Veritas’ lawyers reached out to Slate for a retraction, which was attained in January 2020. This lie about Project Veritas had been cited on Wikipedia and circularly sourced by other “journalists” who wanted to defame our work.

Retractio #308 – Dave Weigel, The Washington Post Jan. 23

Retracto #313 – Robert Marchant, Stamford Advocate May 3

In a March 22, 2020 Stamford Advocate/Greenwich Times article concerning Project Veritas and James O'Keefe titled "Stamford Republicans tap Project Veritas' controversial James O'Keefe for dinner," the Advocate and Greenwich Time reported that, in 2013, O'Keefe "settled a California case accusing him of making a deceptively edited video that falsely depicted a man working for a social-welfare agency as appearing to agree to take part in a human-trafficking scheme."

The lawsuit, which alleged a violation of California's invasion of

privacy law, stemmed from O'Keefe's publication of a video that the California Attorney General described as "severely edited." According to the Attorney General's summary of its report, O'Keefe appeared in the edited video "dressed as a 1970s Superfly pimp, but in his actual taped sessions with ACORN workers, he was dressed in a shirt and tie, presented himself as a law student, and said he planned to use the prostitution proceeds to run for Congress." The man who was the subject of the misleadingly edited video sued O'Keefe for violating California's prohibition against surreptitious video recordings.

Vera's complaint mentioned that the video had been edited but did not state specifically that it had been deceptively edited. In agreeing to settle the case for \$100,000, O'Keefe represented that he "regrets any pain suffered by Mr. Vera or his family," according to court documents.

Retracto #314 – CBS News May 11

CBS News deleted a video report from their website after Project Veritas exposed that the network aired a staged COVID-19 testing line at Cherry Health

Clinic in Grand Rapids, Michigan. President Donald Trump mentioned our report during an Oval Office press availability.

Retracto #315 – The Young Turks May 28

The Young Turks' Emma Vigeland falsely accused Project Veritas of doctoring our report on ABC News senior correspondent David Wright. She also said Project Veritas is a "right-wing hit job smear group." Upon our General Counsel's letter demanding a retraction, The Young Turks deleted the entire episode's video off their page.

Retracto #316 – David McAfee, Law360 June 22

Law360's David McAfee falsely claimed that James O'Keefe pledged to apologize to former ACORN employee Juan Carlos Vera for the videos exposing ACORN's corruption. McAfee had to correct that statement to say that O'Keefe expressed regret for any pain Vera may have incurred as a result of the investigation.

Retracto #317 – Stephen Rex Brown, New York Daily News posted: Aug. 20

Stephen Rex Brown attacks O’Keefe after Gun Story is published. Is forced to retract that O’Keefe is a “convicted felon” and adds comment from Jered Ede that O’Keefe was never convicted of a felony.

Retracto #318 – Cat Zakrzewski, The Washington Post Aug. 21

Cat Zakrzewski claims that Project Veritas’ videos exposing Facebook political censorship is “unsubstantiated.” They add O’Keefe’s comment saying that not a single Project Veritas video has been proved to be deceptively edited or taken out of context.

Retracto #319 – Megan Sheets, Daily Mail Aug. 27

Megan Sheets claimed that Project Veritas is “known to traffic misinformation” and has a “history of pushing misinformation and propaganda.” She also said that James O’Keefe is a conspiracy theorist and practices deceptive editing. She had to delete all of these false statements.

Retracto #320 – Wendy Siegelman Sept. 11

Wendy Siegelman claimed in a tweet that James O’Keefe was fined \$100,000 for the ACORN investigation, which is false. She was forced to delete it.

Retracto #321 – Sonam Sheth, Business Insider Sept. 23

Sonam Sheth claimed that Project Veritas “frequently traffics in misinformation and propaganda” and is known for “deceptively editing videos.” Sonam is forced to add a comment from O’Keefe that Project Veritas does not deceptively edit videos or take videos out of context.

Retracto #322 – Roger Sollenberger, Salon Sept. 23

Roger Sollenberger claimed Project Veritas uses misinformation and deceptively edited videos to take down liberal organizations. Sollenberger had to delete those claims and add O’Keefe statement that not a single video has been proven to be deceptively edited or taken out of context.

Retracto #323 – Darragh Roche, Newsweek Oct. 9

Darragh Roche falsely claimed that Minnesota law allowed for a five-week period of unlimited and unpunished ballot harvesting. Roche also attacked Project Veritas’ credibility in his article. He had to correct that and add an “update” at the bottom of the article.

Retracto #324 – Brennan Weiss, Business Insider Oct. 31

Brennan Weiss claimed that O’Keefe was convicted for tampering with the phones of a former U.S. Senator. Weiss had to change it to: “O’Keefe, after facing a charge he aided and abetted an attempt to tamper...” He also added a new section in the article to admit O’Keefe never tampered with phones.

Retracto #325 – Judd Legum, Popular.info Nov. 1

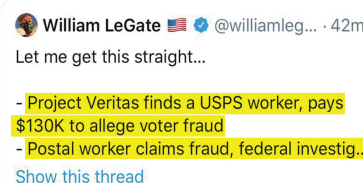

Retracto #326 – Jake Johnson, Salon Nov. 14

Jake Johnson claimed that Project Veritas is “notorious for spreading deceptive footage” in an article about Minnesota. He deleted that sentence and added a correction at the bottom of the article to explain why it was deleted.

Retracto #327 – William LeGate Nov. 16

Twitter personality William LeGate falsely accused Project Veritas of paying \$130,000 to Pennsylvania USPS whistleblower Richard Hopkins to claim voter fraud. LeGate then deleted his tweet upon being confronted and added a clarification tweet saying that the \$130,000 was raised through GoFundMe.

Our ongoing victories paid off as Project Veritas' opponents cut the first of many checks to Project Veritas – resulting in our first Wall of Pain inductee with Steve Wentz. In 2020, Project Veritas' legal team also secured and successfully defended six figures of attorneys' fees awards.

Meanwhile, Project Veritas has taken on some of the most meaningful legal battles in our history. In October, Project Veritas sued the New York Times for a defamatory article claiming that Project Veritas was engaged in a “deceptive ... coordinated disinformation campaign” – a term employed by the Times in retaliation for Project Veritas' journalism overshadowing the Times' own reporting – and launched ExposeNYT.com.

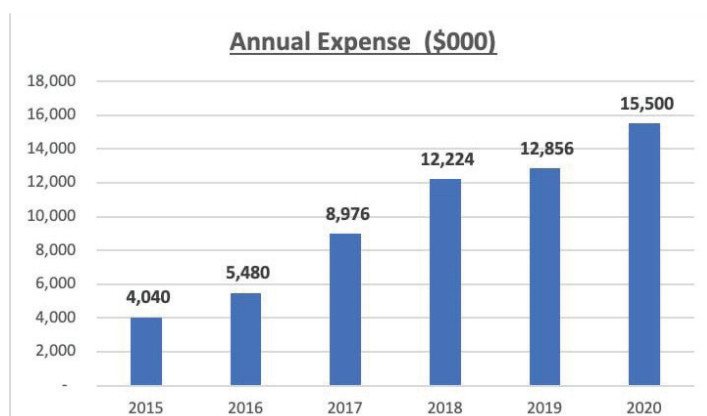
To expand the impact of our journalism, Project Veritas also filed suit to challenge the constitutionality of Oregon's undercover journalism ban.

As we prepare for 2021, Project Veritas remains undefeated in litigation and in its fight for the First Amendment and for truth.

REVENUE

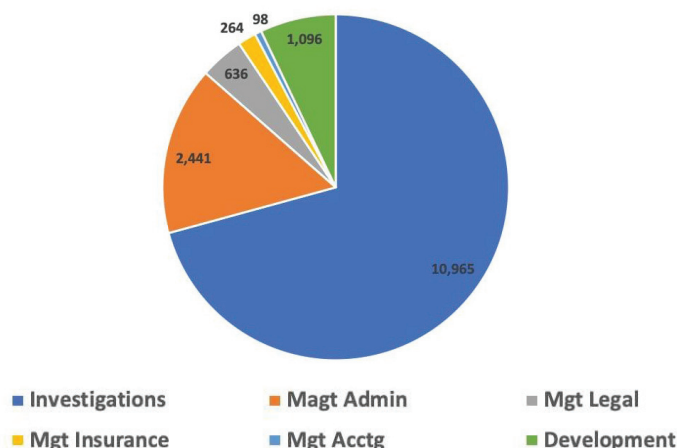
Project Veritas has seen immense growth over the last five years. In 2015, Project Veritas raised \$3,695,349. That number was more than double in a span of two years, when our organization raised \$7,782,773 in 2017. This year, Project Veritas has raised \$17,850,000, proving that our organization is mature and ready to take on all of the powers that be. We have ambitious goals to hit in 2021 and we will continue to leverage these resources to produce impactful stories.



EXPENSES

Over 70% of Project Veritas' revenue was spent on investigations this year. Over the course of the last five years, our spending went from \$3,514,920 to \$14,000,000. The bulk of those expenses went to stories such as #ExposeCNN, #EpsteinCoverup, Minnesota Ballot Harvesting, among other groundbreaking stories.

O'KEEFE VS NYT

Project Veritas Sues The New York Times For Defamation Over Labeling Our Videos 'Deceptive,' 'Coordinated Disinformation,' Using Solely 'Unidentified Sources,' And 'No Verifiable Evidence.'

Project Veritas sued The New York Times after they defamed our work exposing illegal ballot harvesting in Minnesota.

"The Times made this false claim saying our story relied solely on 'unidentified sources.' This is absolute

hogwash, dishonest and libelous," said Project Veritas founder and CEO James O'Keefe.

"The second word of the article about our Minnesota ballot harvesting investigation calls the video 'deceptive,'

but there is nothing in the article to substantiate this libelous claim," he said.

Project Veritas' Chief Legal Officer Jered Ede said that The New York Times reporters Maggie Astor and Tiffany Hsu violated their paper's own Code of Conduct.

"Alleged 'errors,' however are either immaterial or not errors—they are disagreements with the authors' opinions and conclusions," said The New York Times' lawyer. "Word 'deceptive' is not actionable as libel, because it is an opinion."

Project Veritas is undefeated in litigation going into this lawsuit.

rights.

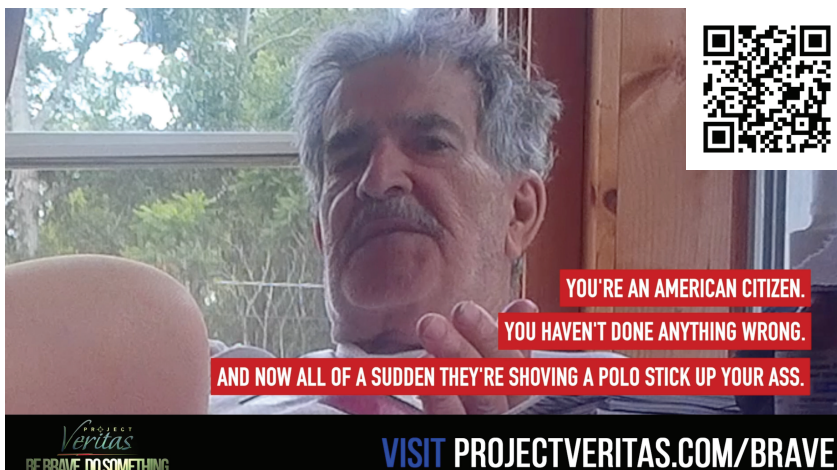
"You probably have a lawsuit on your hands," said a New York gun store clerk to James O'Keefe when he attempted to purchase a firearm at the store.

In another store, a clerk told O'Keefe "they [FBI] don't like you. You're in the newspaper business."

"Throughout this ordeal, I have learned from too many people about the hassles regular Americans have gone through just to exercise their right to keep and bear arms," O'Keefe said.

Upon filing a lawsuit, the FBI promptly removed O'Keefe from the NICS list.

"The FBI removal from NICS is effectively an admission," said Project Veritas Chief Legal Officer Jered Ede.

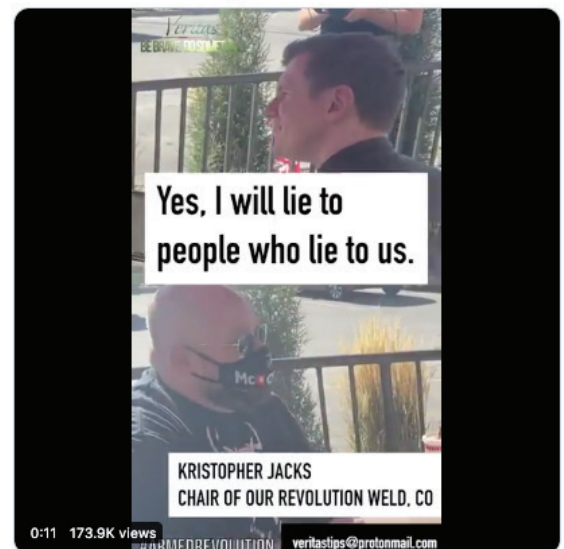

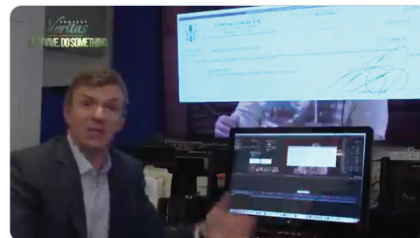

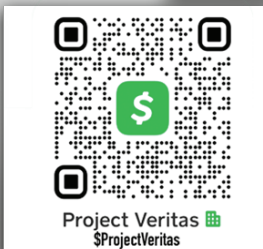
