The undersigned Seller hereby sells, and the undersigned Purchaser ROBERT D. RHODES hereby purchases, subject to the terms and conditions hereof, the following property, with attachments and equipment, delivery and acceptance of which is hereby acknowledged by purchaser, viz.:

for the following payments in lawful money of the United States of America:

\$ 1.00 upon the signing of this agreement, receipt of which is hereby acknowledged, and 18 equal successive monthly installments of THIRTY EIGHT and 32/100 Dollars (\$ 38.32) each, payable on the same day of each month, commencing May 9th, 1932, 193

together with all such other sums as are hereinafter provided for, with interest on such deferred payments from dates of maturity until paid at the highest rate allowed by law. All such payments with interest shall be payable at the office of Palo Alto National Bank in Palo Alto, California

The undersigned purchaser warrants that he has been given credit for certain other cash payments and/or trade allowances totaling \$275.00, which amount together with the above acknowledged cash payment and deferred payments provided for herein represent the total purchase price of the above described automobile.

Purchaser agrees to keep said property insured against loss by fire, theft, transportation, collision and at his own expense for an amount not less than the deferred balance so long as any thereof remains unpaid; such insurance to be placed through agencies or brokers and in insurance companies designated by the seller, loss thereon shall be payable to seller and purchaser as their interests may appear. The purchaser hereby authorizes the seller to pay the premiums for such insurance, adding the same to the deferred principal balance then due hereunder, and the policies therefor shall be held by the seller until this contract is fully performed.

It is expressly agreed and understood between the purchaser and seller that all of the terms and conditions set forth on the reverse side of this agreement form a part of this agreement and contract between the parties.

Should the purchaser fail to make any of the payments herein provided for, or fail to perform any other of the conditions hereof, in the manner or within the time herein specified, the seller or his assignee may at his or its option, and without demand and/or notice of any kind to the purchaser:

- (a) Declare all unpaid amounts immediately due and payable and sue therefor, or
- (b) Retake possession of said property, and without notice resell the same at public or private sale, and after deducting all expenses and attorney's fees incurred therein, credit the net proceeds thereof to the unpaid balance due, and said purchaser agrees to pay to seller, or his assigns any deficiency remaining under this contract after such sale is completed and the net proceeds applied thereon, or
- (c) Retake possession of said property and credit the reasonable value thereof as determined by him to the unpaid amounts due under this agreement, in which event purchaser agrees to pay seller, or his assignees, after said reasonable value of said property has been credited to purchaser's account as aforesaid, any difference or deficiency that may exist or remain due or unpaid, or
- (d) Take immediate possession of said property, wherever the same may be found, and without liability for trespass, in which event all of the rights, titles and equities of the purchaser in, to and under said property and this agreement shall forthwith cease and terminate. Seller shall be forthwith released from all obligations to transfer title or possession of said property to purchaser. All sums of money theretofore paid to seller hereunder shall be and remain the property of the seller, not as a penalty but as compensation for the use by purchaser of said property, and for the depreciation thereof. All sums then due and unpaid under the terms hereof shall be forthwith paid to seller by purchaser as further compensation for the use by purchaser of the said property.

Purchaser agrees to pay the seller any expenses incurred in recovering the possession of said property, or in collecting such unpaid balance of said purchase price, including reasonable attorney's fees, which shall not be less than One Hundred Dollars (\$100.00), and should purchaser fail to pay any installment when due, the seller may refer the collection to any person or collection agency or to the collection department of the seller, or his assignee, and the purchaser agrees to pay the seller a reasonable collection charge, which shall in no event be less than two per cent of said delinquent installment. Purchaser hereby waives the right to move for a change of venue in any action affecting said property or this agreement.

Time is the essence of this agreement.

This agreement is not assignable by the undersigned purchaser except by and with the written consent of the seller and/or assignees and all the terms and conditions herein contained shall apply to and bind the heirs, executors, administrators, assigns and legal representatives of the undersigned purchaser and shall inure to the benefit of the seller's heirs, executors, administrators and assigns.

IT IS UNDERSTOOD THAT THE SELLER OR HIS ASSIGNS SHALL NOT BE BOUND BY ANY AGREEMENT OR REPRESENTATIONS NOT CONTAINED IN THIS AGREEMENT, WHICH THE UNDERSIGNED PURCHASER HAS READ AND UNDERSTANDS.


