

EDUCATION

Across the Museum, this was a year of making art more accessible to all. Free Family Festivals like ¡Descubra! brought thousands together in celebration of culture, creativity, and community—all at no cost to attendees. We relaunched Meet Me at the Museum, a program that offers enriching, connection-centered art experiences for individuals living with dementia and their caregivers. The Art Ark continued to serve as a mobile hub for art education, bringing our Museum-on-wheels to local schools across the region. We introduced Highly Descriptive Tours for visitors who are blind or have low vision and launched a new partnership with Eskaton to expand arts engagement for older adults. Our free-for-everyone Art + Soul Sundays continued to thrive with sold-out sessions month after month, underscoring the power of art to heal and restore. We concluded a California Arts Council grant, which supported inspiring printmaking workshops for thousands of area students. These programs not only opened doors but also built bridges—connecting people, sparking creativity, and proving that art truly belongs to



CURATORIAL

Bold, ambitious, and unforgettable—this year the Museum brought larger-than-life exhibitions that invited visitors to experience art in spectacular new ways. Exhibitions like *David Černý: Rebellion* and *Collidoscope: de la Torre Brothers Retro-Perspective* pushed boundaries and sparked conversation. *Rebellion* captivated audiences and quickly went viral on our social media channels, becoming the content with the most engagement on our pages to date. Additional changing exhibitions showcased a diverse range of art forms, from international photography to renowned examples of French drawing and painting. The permanent collection received some of the most significant donations in the Museum's history, with works spanning from antiquity to the present day and representation across six continents.
