#### Methodology





#### **Research Objective:**

To understand the perspectives of key decision-makers in the business sector regarding reforms, the effectiveness of anti-corruption efforts, and business development in Ukraine.



#### Sample Size:

75 respondents.



#### **Target Audience:**

Owners, executives, and top management of medium and large businesses in Ukraine.



#### **Survey Period:**

January 13-24, 2025.



#### **Survey Method:**

An online survey conducted by sending questionnaires to a selected group of respondents.



#### **Data Collection:**

Data collected by "Gradus Research".

The survey was conducted among owners and top executives of leading companies operating in Ukraine, representing a wide range of industries, including finance, investment, agribusiness, technology, logistics, manufacturing, consulting, and legal services. Among the participants are business leaders whose companies are among the largest in Ukraine, leading their respective industries and making significant contributions to economic development, innovation, and social initiatives. Many of them are featured in rankings by Forbes, EY, and Deloitte, and their companies have international recognition, setting trends in their industries. To maintain the anonymity of respondents, the specific names of the companies are not disclosed, however they play a key role in the market. These companies not only shape Ukraine's economic landscape but also actively develop innovative solutions, invest in the future, and implement advanced business practices on a global scale.

#### **Key Findings**



#### 1 Implementation of Reforms: Support for the General Course but Doubts About Government Efficiency

- 61% of respondents believe that Ukraine is moving in the right direction in implementing reforms in line with international commitments (to the EU, IMF, World Bank, etc.). This indicates a relatively high level of trust in the overall course of reforms in Ukraine. Additionally, 53% assess reform progress in 2024 as "moderate" or "high", while only 14% believe there has been no progress.
- At the same time, **58**% of respondents consider the government of Ukrainian Prime Minister D. Shmyhal ineffective in implementing these reforms: **37**% rate its work as "rather ineffective", and **21**% as "completely ineffective". This highlights significant business distrust in the government's ability to carry out reforms effectively.

#### 2 Impact of Reforms on Business: Cautious Optimism

• **56**% of respondents note a positive impact of reforms on their business operations. Among them, **47**% consider this impact "rather positively", and **9**% see it as "very positively". This suggests that overall, reforms contribute to business development. However, a significant share of entrepreneurs (**28**%) see no improvements or remain skeptical about the effectiveness of changes.

#### 3 Corruption: Lack of Trust in Anti-Corruption Efforts but Limited Personal Experience with Corrupt Practices

- 53% of respondents do not believe that corruption levels in Ukraine decreased in 2024. This reflects a lack of business confidence in the government's anti-corruption efforts. However, 53% also reported that they had not encountered corruption from state authorities in the past month. Nonetheless, 34% had personally experienced or heard from acquaintances about corruption incidents.
- Additionally, **46**% assess the ability of businesses to participate in public tenders without corruption risks as low. This suggests that public procurement remains an area of heightened corruption risks for entrepreneurs.



## 4 Assessment of State Authorities: Moderate Integrity but Mixed Opinions on the Performance of Specific Agencies

- 61% of respondents rate the integrity of state authorities in their interactions with businesses as moderate. Meanwhile, 21% consider it high.
- Regarding the State Customs Service, **39**% of respondents believe its performance remained unchanged in 2024, while **17**% noted deterioration.
- Opinions on state property management efficiency in 2024 were divided: 36% think it improved, while 32% believe it deteriorated.

#### 5 Political and Economic Expectations from the New U.S. President: Mostly Positive Outlook

• 54% of respondents expect Donald Trump's potential influence on Ukraine's political and economic situation to be positive. Among them, 47% consider it "moderate positive", while 7% see it as "significant positive". Meanwhile, 30% anticipate negative consequences. These figures suggest a cautious optimism among businesses regarding future U.S. policy toward Ukraine.

#### 6 Economic Situation: Business Feels Negative Pressure from the Current Economic Environment

• 63% of respondents negatively assess the impact of the current economic situation on their operations. Among them, 44% describe this impact as "rather negatively", and 19% as "very negatively". Only 16% view it positively. These results indicate significant economic challenges faced by businesses in Ukraine, likely linked to macroeconomic instability, high business costs, and the impact of the war.




Corruption by government agencies



How do you assess the ability of your business to participate in public tenders without the risks of corruption, unfair competition, and similar threats?








46% of respondents rate the ability of their business to participate in public tenders without corruption risks, unfair competition, and similar threats as low. Among them, 32% consider these opportunities rather low, while 14% see them as very low.

53% of respondents do not believe that the level of corruption in Ukraine decreased in 2024 compared to previous years.




How do you assess the level of \*integrity in the work of state authorities in their interactions with your business at the moment?



61% of respondents assess the level of integrity in the work of state authorities in their interactions with their business as moderate, while 21% consider it high.

53% have not encountered corruption from state authorities in the past month, whereas 34% have experienced such cases.

\*Corruption refers to bribery, illegal demands, granting of privileges, or other unlawful actions.



How reforms affect business




Do you believe that, overall, the process of implementing reforms in Ukraine in line with its \*international commitments is moving in the right or wrong direction?



\*International commitments primarily refer to obligations toward the EU, IMF, and World Bank.


61% of respondents believe that the overall process of implementing reforms in Ukraine in line with international commitments is moving in the right direction, while 21% hold the opposite view.




58% believe that the government under Prime Minister D. Shmyhal is ineffective in implementing reforms, with 37% rating its work as rather ineffective and 21% as completely ineffective. Overall, 28% of respondents consider the government's reform efforts effective.

39% of respondents assess Ukraine's progress in implementing reforms in 2024 in line with international commitments as moderate. 14% give it a high rating, while another 14% believe there has been no progress at all.

56% of respondents perceive the impact of these reforms on their business positively: 47% rate it as rather positive, while 9% see it as very positive.




Impact of political changes in the USA

54% of respondents positively assess the potential impact of D.Trump on Ukraine's political and economic situation over the next 12 months. Among them, 47% believe Ukraine will experience a moderate positive impact, while 7% expect a significant positive impact. Meanwhile, 30% of respondents anticipate a negative impact.

63% of respondents negatively assess the impact of Ukraine's current economic situation on their business: 44% consider it rather negative, while 19% see it as very negative. Only 16% view this impact as positive.

How do you assess the effectiveness of state property management in Ukraine in 2024 compared to previous years?





39% of respondents believe that the quality of work of the State Customs Service of Ukraine in 2024 remained unchanged. Meanwhile, 17% noted an improvement, and another 17% observed a deterioration in its quality.

36% believe that the effectiveness of state property management in Ukraine improved in 2024, while 32% think it worsened.


